1. NOW THIS INDENTURE WITNESSETH AS FOLLOWS








1.1 THAT the name of the trust shall be "R.G. RAO EDUCATIONAL TRUST" and its principal office shall be situated at 8-2-277/53, UNION BANK COLONY, ROAD NO:3, BANJARA HILLS, HYDERABAD-500034

or such other place as the Trustees may from time to time decide. The trust may also carry on its work at any other place or places, as decided by the Board of Trustees.

1.2 THAT THE SETTLOR above named to effectuate the said objective of creating, establishing and managing the above mentioned Trust, have settled a sum of **Rs. 10,00,000/- (Rupees Ten Lakhs only)**, irrevocably with intent to part with all his rights, titles and interests, claims, demands, profits therein and vest the same in the Trustees to have and to hold the same together with all other property or properties that may be acquired out of the same or otherwise may hereafter be subject to the trust (hereinafter referred to as "The Trust Fund") for the trust objectives and purposes and uses hereinafter expressed with the powers and on the terms and conditions herein contained, concerning the same.

1.3 It is also declared and clarified that no legal heir/successor of the Settlor can have any claim at any point of time over the properties and the properties to be acquired from time to time by the Trust contrary to the expressions both expressly or impliedly made in this deed.








2. OBJECTS: The objectives of the Trust are:

2.1 To establish, maintain, run, improve, extend, grant donations for and to aid and assist in the establishment, maintenance running, development, improvement and extension of Pre-primary , Primary Schools, Middle school , Higher Secondary schools, Colleges, Universities, Workshops, Weaving industrial, technological and other Art, Craft and Science Institutes, Schools and Institutions of Telugu or Sanskrit Learning, Hostels for the benefit of students and generally all kinds of educational institutions whether general, technical, vocational, professional or of other description whatsoever for the welfare and upliftment of the general Indian public and to institute award scholarships in India for study, research, apprenticeship for all or any of the said purposes.

2.2 To open, fund, establish, promote, set up, run, take over, maintain, support and / or help in setting up, maintenance and / or administration of educational institutions for imparting education and / or training in the fields of academic, professional, technical, engineering, medical including under the Indian medical systems like Ayurveda, Homeopathy, Siddha, Yoga, Pharmacy, etc., and health sciences including medical, dental, paramedical, nursing courses, management studies, information technology and computer, vocational courses, etc.







3.8 To invest money not immediately required, for the purpose of fulfillment of its objects in accordance with the provisions of the Income Tax Act 1961, in particular the provisions sec 11 (5) of the Act.



4. PROPERTIES:
